The renewal ICE qualifies for 1.5 BCRPA CECs. Upload the completed ICE form on the Registry under *Pre-Approved CEC*. The '**Date**' is the date of your ICE. Enter 1.5 under '**Hours**' and the name of your ICE Evaluator will be the '**Presenter**'. Contact BCRPA directly for more information.

The Osteofit ICE is valid for 3 years and must be renewed to maintain your registration and your liability insurance. Be sure to record the expiry date of your ICE. If your ICE expires, your BCRPA liability insurance to lead Osteofit programs will be void.
